BREEDING CONTRACT

1. Mare owner hereby confirms the reservation for a service in _____ to the P.R.E. stallion KLICKITAT (hereinafter referred to as "the stallion"), owned by Pamela Nelson (hereinafter referred to as "stallion owner") and standing at Villa Rosa, Hollister, CA for the mare:

2. The stallion service fee is: \$ _____. Included in this fee is a \$500.00 non-refundable booking fee. The full fee is due on return of this contract.

3. Mares are subject to approval of stallion owner, as bookings are very limited. Mare owner understands that the mare will not be accepted for breeding without satisfactory evidence that A) she is free from all contagious and infectious diseases; B) a satisfactory pronouncement from a licensed veterinarian that she is in good breeding condition; C) a uterine culture is recommended, but not required on a maiden mare (who has not been exposed to a stallion).

4. Mare owner agrees to secure the services of a qualified veterinarian for this mare and any examinations deemed necessary to further the possibility of pregnancy in the mare are at the expense of the mare owner. Including but not limited to: the routine practice of biopsy, culture and necessary treatment if the mare does not conceive after breeding on two heat periods.

5. Live Foal Guarantee: Mare owner understands that should this mare not deliver a live foal, that can stand up alone and nurse, that in the year following the breeding, provided mare owner submits to Pamela Nelson a satisfactory veterinary certificate, mare owner shall be entitled to a live foal guarantee. Protocol: Transported fresh semen at the convenience of the stallion owner. All shipping and cooling costs must be paid by the mare owner. This semen is applicable to the same mare or a suitable substitute mare upon the approval of the stallion owner, within the next year only. This live foal guarantee is dependent upon the mare owner inoculating the mare against Rhinopneumonitis in the 5th, 7th, and 9th months of pregnancy. These inoculations must be documented by a licensed veterinarian.

6. This breeding contract cannot be assigned, sold, cancelled or transferred by mare owner without written agreement by stallion owner. In the event the mare is sold, no refund shall be due from Pamela Nelson, under any circumstances.

7. Mare owner understands that should the stallion die, or otherwise become unfit for service, prior to servicing this

mare, or if the mare dies or becomes unfit to be bred prior to being serviced, this contract is and shall be null and void and the breeding fee returned (less the booking fee).

Should the stallion die or become un-breedable after the mare is serviced, and no live foal results, then the breeding fee will be returned (less the booking fee).

8. Stallion owner assumes all risk of loss or damage to her stallion, and mare owner assumes all risk of loss or damage to his/her mare and his/her foal; each will insure against such loss at his/her discretion.

9. All breeding will be done by artificial insemination. Mare owner will pay all cost to collect, ship & inseminate the mare. The stallion owner will transport the stallion to the veterinarian, to be collected, at no cost to the mare owner. The mare owner understands that KCLICKITAT will only be collected by Dr. Richard McCormick, Valley Equine, Gilroy, CA (408)847-3118.

10. In the event this breeding is conducted via Transported Semen, the mare owner will be responsible for all veterinary cost involved in preparing the mare, all normal veterinary costs incurred in collecting the stallion, preparing the semen, and costs for shipping and return of the containers. The mare owner is aware that this may include substantial deposit fees for containers and FedEx costs.

This contract is executed in duplicate and shall be legally binding on the parties hereto, and their heirs, executors, administrators and assigns.
